HEALTH CARE: Transfers powers and duties of the Nursing Supply and Demand Council and the Simulation Medical Training and Education Council to the Louisiana Health Works Commission

1	AN ACT
2	To amend and reenact R.S. 17:2048.51(B), (C)(9) and (14), and (G) and to repeal Part IV-C
3	of Chapter 9 of Title 17 of the Louisiana Revised Statutes of 1950, comprised of R.S.
4	17:2048.61, R.S. 36:651(L)(1)(b) and (c), and Subpart C of Part III of Chapter 11 of
5	Title 37 of the Louisiana Revised Statutes of 1950, comprised of R.S. 37:1007,
6	relative to health care workforce development; to provide for the Louisiana Health
7	Works Commission; to provide for its membership; to provide for committees of the
8	commission; to abolish the Nursing Supply and Demand Council; to abolish the
9	Simulation Medical Training and Education Council for Louisiana; and to provide
10	for related matters.
11	Be it enacted by the Legislature of Louisiana:
12	Section 1. R.S. 17:2048.51(B), (C)(9) and (14), and (G) are hereby amended and
13	reenacted to read as follows:
14	§2048.51. Louisiana Health Works Commission; creation; membership;
15	compensation; staff and facilities; powers and duties; data collection and
16	reporting

18	B. The purpose of the commission is to serve as a collaborative working
19	group to integrate and coordinate resources relative to health care workforce

1	development within various state departments and key organizations and to carry out
2	those duties previously assigned to the Nursing Supply and Demand Council and the
3	Simulation Medical Training and Education Council for Louisiana.
4	C. The following shall serve as members of the Louisiana Health Works
5	Commission:

19	or his designee for the commission.
20	(3) (iii) The president of the University of Louisiana System or his designee

22	(4) (iv) The dean of the School of Allied Health Professions at Louisiana
23	State University Health Sciences Center at Shreveport or his designee for the
24	commission.

28	or his designee.

13	H. (b) The executive committee shall:	
14	(1) (i) Elect the chairperson of the commission. The chair of the Nursing	
15	Supply and Demand Committee shall serve as the vice chair of the commission.	
16	(2) (ii) Establish rules of procedure to be adopted in accordance with the	
17	Administrative Procedure Act.	
18	(3) (iii) Perform other tasks as the commission directs or the adopted rules	
19	of procedure require.	
20	(2) A Nursing Supply and Demand Committee, to consist of representatives	
21	of all organizations previously represented on the Nursing Supply and Demand	
22	Council who are not represented on the Health Works Commission, in addition to	
23	any other members of the Health Works Commission as appointed by its chair.	
24	(3) A Simulation Medical Training and Education Committee, to consist of	
25	representatives of all organizations previously represented on the Simulation Medical	
26	Training and Education Council who are not represented on the Health Works	
27	Commission, any members of the Health Works Commission as may be appointed	
28	by its chair, and the following members:

4	Section 2. R.S. 17:2048.61, Part IV-C of Chapter 9 of Title 17 of the Louisiana
5	Revised Statutes of 1950, comprised of R.S. 17:2048.61, R.S. 36:651(L)(1)(b) and (c), and
6	Subpart C of Part III of Chapter 11 of Title 37 of the Louisiana Revised Statutes of 1950,
7	comprised of R.S. 37:1007, are hereby repealed in their entirety.
8	Section 3. This Act shall become effective upon signature by the governor or, if not
9	signed by the governor, upon expiration of the time for bills to become law without signature
10	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
11	vetoed by the governor and subsequently approved by the legislature, this Act shall become
12	effective on the day following such approval.

Abstract: Abolishes the Nursing Supply and Demand Council and the Simulation Medical Training and Education Council for La. and provides for the La. Health Works Commission.

<u>Present law</u> creates the La. Health Works Commission (commission) and provides for its purpose, membership, and powers and duties.

<u>Proposed law</u> retains <u>present law</u> and adds to the duties that the commission will carry out the duties once assigned to the Nursing Supply and Demand Council and the Simulation Medical Training and Education Council for La.

Present law provides for the membership of the commission.

Proposed law adds two members to the commission.

<u>Present law</u> establishes an executive committee for the commission and provides for the composition of that committee.

<u>Proposed law</u> creates two additional committees within the commission, the Nursing Supply and Demand Committee and the Simulation Medical Training and Education Committee, and provides for the composition of those committees.

<u>Present law</u> provides for the Simulation Medical Training and Education Council for La., its purpose, membership, and reporting requirements.
