| 5 | his legendary coaching career, he has amassed an incredible 1,162-355 career record and |

| 7 | WHEREAS, this past season, Coach Broussard led the Cougars to the team's thirty- |
| 8 | fourth-consecutive playoff appearance, which also marks the program's forty-first playoff |
| 9 | appearance in St. Thomas More Catholic High School's forty-three-year history; the Cougars |
| 10 | have averaged an astounding twenty-eight wins per season over the course of his coaching |
| 11 | career; and |
| 12 | WHEREAS, Coach Broussard led the Cougars to state championship victories in |
| 13 | 1986, 2013, 2018, 2019, 2020, and 2021, and his teams have made nineteen LHSAA Final |
| 14 | Four appearances; his teams also finished as the state runner-up in 1987, 1999, 2003, 2024, |
| 15 | and 2025; and |
| 16 | WHEREAS, Coach Broussard has received numerous awards and accolades for his |
| 17 | outstanding coaching success; he was named the 1986 Class 3A Coach of the Year, the 1997 |
| 18 | Class 4A Coach of the Year, the 1999 Class 4A Coach of the Year, and the 2013 NOLA.com |
| 19 | Coach of the Year; he is a nine-time All-Acadiana Coach of the Year, ten-time Lafayette |
| 20 | Parish Outstanding Coach, and twenty-six-time District Coach of the Year; his most |

HR NO. 85 1 cherished awards are the 1991 STM Teacher of the Year and the 1991 Diocese of Lafayette 2 Teacher of the Year; and 3 WHEREAS, Coach Broussard was inducted into the Louisiana High School 4 Basketball Coaches Association Hall of Fame in 2018; in 2021, he was recognized as the 5 NHSACA Boys Basketball Coach of the Year, and in 2022, he was one of eight finalists for 6 the National Coach of the Year Award; and 7 WHEREAS, Coach Broussard led the West Team to victory during the McDonald's 8 All-American Game at the Barclays Center in Brooklyn, New York, in April 2025, and he 9 will be inducted into the Louisiana Sports Hall of Fame in June 2025; and 10 WHEREAS, Coach Broussard has shared forty-two years of marriage with Dena 11 Landry Broussard; they are the proud parents of Lacey, Paige, and Chase, and grandparents 12 of Mills and Henry; and 13 WHEREAS, Coach Broussard has the third-most career wins among active head 14 coaches in United States high school basketball; according to the National Federation of 15 State High School Associations, he is ranked sixth nationally for all-time wins as a high 16 school basketball coach, which is twenty-five wins behind legendary basketball coach, Bob 17 Hurley; and 18 19

WHEREAS, Coach Danny Broussard is a truly outstanding leader who is most deserving of the highest recognition for his legendary coaching career and massive contributions to Louisiana high school basketball.
