2	To commend the Louisiana Foundation Against Sexual Assault and to designate
3	Wednesday, April 30, 2025, as Denim Day at the Louisiana State Capitol.
4	WHEREAS, on April 24, 1998, a sexual assault case in Italy sparked a worldwide
5	movement after a court ruled that a woman was not assaulted because her jeans were deemed
6	too tight, perpetuating harmful accusations and victim-blaming; and
7	WHEREAS, this outrageous ruling highlighted the urgent need to challenge societal
8	attitudes toward sexual violence and advocate for justice and support for survivors; and
9	WHEREAS, Denim Day emerged as a powerful symbol of protest against sexual
10	assault, inviting individuals globally to wear denim to stand in solidarity with survivors and
11	to raise awareness about consent and the importance of putting an end to victim-blaming;

13	WHEREAS, on this day we honor sexual assault survivors and strengthen our
14	commitment to creating a world free of sexual violence, where every individual is treated
15	with respect and integrity.
16	WHEREAS, the Louisiana Foundation Against Sexual Assault (LaFASA), led by its
17	executive director, Rafael de Castro, is committed to empowering survivors, engaging
18	advocates, and changing systems and social norms to end sexual violence in Louisiana; and
