HOUSE RESOLUTION NO. 251

BY REPRESENTATIVE ECHOLS

SCHOOLS/CHARTER: Requests that the State Board of Elementary and Secondary Education study and report relative to the voting threshold required for parental approval for the conversion of a preexisting school to a charter school

1 A RESOLUTION 2 To urge and request the State Board of Elementary and Secondary Education to study the 3 voting threshold required by law for parental approval relative to the conversion of 4 a preexisting school to a charter school and to submit a written report of findings and 5 conclusions, including but not limited to recommendations for legislation pertaining 6 to the potential modification of this requirement, to the House Committee on 7 Education not later than January 31, 2026. 8 WHEREAS, present law provides that the purposes of the Louisiana Public Charter 9 School Law (R.S. 17:3971 et seq.) are to increase school choice options throughout the state 10 and to provide opportunities for parents, educators, and others to form, operate, or be 11 employed within an operationally autonomous charter school designed to accomplish certain 12 educational objectives; and 13 WHEREAS, this law provides for various types of charter schools, including 14 preexisting schools that are converted to charter schools, and provides a process for 15 conversion, including a requirement relative to parental approval; and 16 WHEREAS, the law provides that approval by the parents of students attending a 17 preexisting school proposed to be converted to a charter school requires a favorable vote of 18 the majority of the parents of students enrolled in the school at the time of the election who 19 are voting, provided the number of votes cast equals at least fifty percent of the number of HLS 25RS-3462 ENGROSSED

1 students; the law further provides that there shall be one vote for each student enrolled in the 2 school which may be cast by one parent for each student; and 3 WHEREAS, concern has been expressed that it can be challenging for parents in 4 rural schools to participate in school-wide votes and to meet the voting threshold required 5 by law. 6 THEREFORE, BE IT RESOLVED that the House of Representatives of the 7 Legislature of Louisiana does hereby urge and request the State Board of Elementary and 8 Secondary Education to study the voting threshold required by law for parental approval 9 relative to the conversion of a preexisting school to a charter school and submit a written 10 report of findings and conclusions to the House Committee on Education not later than 11 January 31, 2026. 12 BE IT FURTHER RESOLVED that the report include recommendations for 13 legislation for how this requirement might be modified in order to better meet the needs of 14 Louisiana's students and fulfill the purposes of the Louisiana Public Charter School Law.

BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the president of the State Board of Elementary and Secondary Education and the state superintendent of education.
