2 Delete House Committee Amendments Nos. 1 and 3 by the House Committee on Municipal,  
3 Parochial and Cultural Affairs (#4074)

4 AMENDMENT NO. 2

5 On page 1, line 2, after "To" and before "relative to" delete "enact R.S. 33:4761(A) and (B),"  
6 and insert "amend and reenact R.S. 19:136 and 136.1(3) and R.S. 33:4761 and to enact R.S.  
7 13:2575(B)(3)(g),"

8 AMENDMENT NO. 3

9 On page 1, line 4, after "Rouge;" and before "to provide" insert "to provide relative to  
10 blighted properties in municipalities within the parish;"

11 AMENDMENT NO. 4

12 On page 1, line 5, after "demolish," and before "dilapidated" delete "or remove" and insert  
13 "remove, or expropriate"

14 AMENDMENT NO. 5

15 On page 1, line 6, after "structures;" delete the remainder of the line and at the beginning of  
16 line 7, delete "exceptions;" and insert "to provide relative to administrative adjudication  
17 procedures;"

18 AMENDMENT NO. 6

19 In Amendment No. 2 by the House Committee on Municipal, Parochial and Cultural Affairs  
20 (#4074) on page 1, between lines 20 and 21, insert the following:

21 "Section 2. R.S. 19:136 and 136.1(3) are hereby amended and reenacted to read as  
22 follows:

23 **PART III-G. EXPROPRIATION OF ABANDONED OR BLIGHTED PROPERTY**  
24 **BY A DECLARATION OF TAKING BY THE CITY OF NEW ORLEANS, ~~AND~~**  
25 **THE CITY OF GRAMBLING, AND THE PARISH OF EAST BATON ROUGE**  
26 **AND ITS MUNICIPALITIES**

27 §136. Purpose

28 In an effort to control the rising number of abandoned or blighted properties  
29 throughout the state and to slow urban blight, the legislature finds it necessary to  
30 implement a mechanism by which the city of New Orleans, ~~and~~ the city of  
31 Grambling, ~~and the parish of East Baton Rouge and its municipalities~~ are  
32 empowered to more readily obtain abandoned or blighted properties. The provisions  
33 of this Part are intended to provide a means by which governing authorities may

1 revitalize economically depressed areas by placing abandoned or blighted properties  
2 back into the economic stream of commerce through the rehabilitation of the  
3 abandoned or blighted property. The procedure created by this Part shall be in  
4 addition to any other procedure authorized by law.

5 §136.1. Definitions

6 For the purposes of this Part, unless the context clearly otherwise requires or  
7 unless otherwise defined in specific portions of this Part, the following words or  
8 phrases shall have the respective meanings:

10 (3) "Governing authority" means the city of New Orleans or any assignee  
11 thereof which is authorized by the municipality to carry out the purpose of this Part,  
12 ~~or the city of Grambling,~~ **or the parish of East Baton Rouge or its municipalities.**
