A CONCURRENT RESOLUTION

To express the sincere and heartfelt condolences of the Legislature of Louisiana upon the death of retired Louisiana Supreme Court Justice Harry T. Lemmon.

WHEREAS, it is with profound sorrow that the Legislature of Louisiana has learned of the passing of retired Louisiana Supreme Court Justice Harry T. Lemmon on Friday, April 18, 2025, at the age of ninety-four; and

WHEREAS, born on December 11, 1930, in Morgan City, Louisiana, Harry T. Lemmon earned his undergraduate degree from Southwestern Louisiana Institute (now the University of Louisiana at Lafayette), where he received the Alumni Award as the outstanding graduate; and

WHEREAS, following his early professional career as a chemist and two years of honorable service in the United States Army, Justice Lemmon pursued his legal education at Loyola University New Orleans College of Law, graduating *cum laude*; and

WHEREAS, upon entering legal practice, he joined the firm of Vial, Vial and Lemmon in Hahnville, Louisiana, before launching a distinguished judicial career that began with his 1970 election to the Court of Appeal, Fourth Circuit; and

WHEREAS, Justice Lemmon served with honor and distinction on the Louisiana Supreme Court for twenty-one years from May 16, 1980, until his retirement on May 16, 2001; and

WHEREAS, beyond the bench, Justice Lemmon was a passionate legal educator, serving pro bono as an adjunct professor at Loyola University New Orleans College of Law and teaching at both Louisiana State University's Paul M. Hebert Law Center and Tulane University Law School; and

WHEREAS, he chaired the Ainsworth Lecture Committee, brought global legal perspectives to Louisiana students and faculty, and contributed to curriculum development as a member of Loyola's Visiting Committee; and

WHEREAS, his commitment to the continuing education of judges and legal professionals was evident through his two decades as Chair of the Board of Governors of the Louisiana Judicial College and as Chair of the American Bar Association Committee on Continuing Education for Appellate Judges; and

WHEREAS, Justice Lemmon co-authored the Louisiana Civil Law Treatise on Civil Procedure and served on multiple committees of the Louisiana State Law Institute, influencing the development of civil and criminal procedure, community property, and conflict of laws in Louisiana; and

WHEREAS, he was nationally recognized for his ethics and leadership, serving on the Board of Directors of the American Judicature Society and the Advisory Board of the National Center for Judicial Ethics; and

WHEREAS, his many honors include the St. Ives Award from Loyola Law School, the Louisiana Bar Foundation's Distinguished Jurist Award, an honorary Doctor of Laws degree from Loyola, honorary alumni status from the LSU Law Center, induction into the LSU Law Center Hall of Fame, and membership in the Order of the Coif and the Morgan City High School Athletic Hall of Fame; and

WHEREAS, Justice Lemmon was a devoted husband to his wife of sixty-four years, the Honorable Mary Ann Vial Lemmon, a U.S. District Judge for the Eastern District of Louisiana, and a loving father and grandfather to his six children: Andrew, Mary Lauren, Roslyn, Carla, Jake, and Patrick, and to thirteen grandchildren.

THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby express sincere and heartfelt condolences upon the death of Justice Harry T. Lemmon.

BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to Justice Harry Lemmon's wife, the Honorable Mary Ann Vial Lemmon.
