

1 delinquent taxpayer having three years from the recordation of the tax lien certificate to pay
2 the taxes and extinguish the tax lien; and

3 WHEREAS, notwithstanding reforms in the tax sale process, instances of local
4 governments adjudicating tax-delinquent property for long periods of time result in the
5 withdrawal of the property from commerce; and

6 WHEREAS, the citizens of Louisiana would benefit from a revised tax sale process
7 that more efficiently reintroduces tax-delinquent property into commerce, particularly for
8 parties who will subsequently rehabilitate and add value to the property; and

9 WHEREAS, to promote rehabilitation of tax-delinquent property and to expedite the
10 reintroduction of tax-delinquent property into commerce, the Louisiana State Law Institute
11 should study the feasibility of expediting the sale of tax-delinquent property that has been
12 adjudicated for extended periods of time to parties that will rehabilitate the property; and

13 WHEREAS, such study should include recommended revisions to the state
14 constitution and laws as may be necessary in the form of specific proposed legislation.

15 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
16 urge and request the Louisiana State Law Institute to study and recommend legislation to
17 expedite the sale of tax-delinquent property that has been adjudicated for extended periods
18 of time to parties that will rehabilitate the property and report its findings and
19 recommendations to the legislature no later than January 1, 2027.

20 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
21 director of the Louisiana State Law Institute.

22 BE IT FURTHER RESOLVED that the Louisiana State Law Institute shall submit
23 one print copy and one electronic copy of any report produced pursuant to this Resolution
24 to the David R. Poynter Legislative Research Library pursuant to R.S. 24:772.
