Reforms certain powers, duties, and responsibilities in the office of Louisiana Highway Construction

Current law provides for the Office of Louisiana Highway Construction and grants it exclusive authority over agreements with local governments for non-federal-aid routes. Proposed law authorizes the Office of Louisiana Highway Construction to execute the design, construction, remediation, rehabilitation, or replacement of any segment of federal-aid highway through a mutual letter of agreement with the Department of Transportation and Development; grants control and oversight of the State Highway Improvement Fund to the Office of Louisiana Highway Construction; provides for the powers of the executive director of the Office of Louisiana Highway Construction; and updates the duties of the Office of Louisiana Highway Construction.

EXPENDITURE EXPLANATION


There is no anticipated direct material effect on governmental expenditures as a result of this measure. Proposed law shifts the authority and control of the State Highway Improvement Fund to the Office of Louisiana Highway Construction and allows the office to execute the design, construction, remediation, rehabilitation, or replacement of any segment of federal-aid highway through a mutual letter of agreement with the Department of Transportation and Development. The LFO assumes any expenditures associated with the State Highway Improvement Fund and any federal-aid highway project (likely from the Transportation Trust Fund) will shift from the Department of Transportation and Development to the Office of Louisiana Highway Construction.

There is no anticipated direct material effect on governmental revenues as a result of this measure.
