**HOUSE FLOOR AMENDMENTS**

Amendments proposed by Representative Fontenot to Engrossed House Bill No. 393 by Representative Fontenot

1 AMENDMENT NO. 1

2 On page 1, line 2, after "Constitution of" and before "relative" delete "Louisiana," and insert  
3 "Louisiana and to repeal Article VI, Section 30(B) of the Constitution of Louisiana,"

4 AMENDMENT NO. 2

5 On page 1, delete line 4 and insert the following:

6 "elections, parcel fee elections, and gaming elections; to provide for such elections  
7 to be held only during a regularly scheduled open primary election; to repeal  
8 provisions prohibiting a political subdivision from submitting the same tax  
9 proposition to the electorate more than once in a six month period except in the case  
10 of an emergency;"

11 AMENDMENT NO. 3

12 On page 1, line 20, after "finance," and before "the election" insert "a fee imposed within a  
13 special district, the primary purpose of which is provided for in Article III, Section 13(B) of  
14 this Constitution, or gaming, gambling, or wagering,"

15 AMENDMENT NO. 4

16 On page 2, delete lines 1 through 6 and insert the following:

17 "scheduled open primary election. The legislature may provide by law enacted by  
18 two-thirds of the elected members of each house of the legislature for the calling of  
19 special elections in the case of an emergency."

20 Section 2. Be it resolved by the Legislature of Louisiana, two-thirds of the  
21 members elected to each house concurring, that there shall be submitted to the  
22 electors of the state of Louisiana, for their approval or rejection in the manner  
23 provided by law, a proposal to repeal Article VI, Section 30(B) of the Constitution  
24 of Louisiana."

25 AMENDMENT NO. 5

26 On page 2, line 7, change "Section 2." to "Section 3."

27 AMENDMENT NO. 6

28 On page 2, at the end of line 8, change "2028." to "2029."

29 AMENDMENT NO. 7

30 On page 2, line 9. change "Section 3." to "Section 4."

1 AMENDMENT NO. 8

2 On page 2, line 12, change "Section 4." to "Section 5."

3 AMENDMENT NO. 9

4 On page 2, delete lines 16 through 20 and insert the following:

5 "Do you support an amendment to require that any local bond or tax election,  
6 parcel fee election, or gaming election be held only during a regularly scheduled  
7 open primary election and to repeal the prohibition against a political subdivision  
8 submitting the same tax proposition to the electorate more than once in a six month  
9 period except in the case of an emergency? (Amends Article VI, Section 22; Repeals  
10 Article VI, Section 30(B))"
