Subject: Operating a Motor Vehicle Using Wireless Phone		

MTR VEHICLE/VIOLATIONS RE NO IMPACT See Note Page 1 of 1
 Defines the term "school zone" relative to the operation of a motor vehicle while using a wireless telecommunication device

Current law prohibits the operation of a wireless telecommunications device while operating a motor vehicle unless the vehicle is lawfully stationary; assesses a fine of \$250 for those who operate a wireless telecommunications device while operating a motor vehicle in a school zone (or at the judge's discretion, the fine may be reduced to \$100 with community service not to exceed 15 hours, at least half of which shall consist of a litter abatement program in a school zone or highway construction zone), and for those involved in a crash at the time of the violation, a fine equal to \$500 (or \$200 with the same community service stipulations) and the law enforcement officer investigating the crash shall indicate on the written accident report that the person was using a wireless telecommunications device at the time of the crash. Proposed law defines school zone as any designated area adjacent to a public or private kindergarten through 12th grade school or post-secondary institution that is properly marked with official school warning or similar traffic control signage, including signage provided in Chapter 7 of the DOTD Traffic Engineering Manual relating to schools, and extending not less than 250 feet prior to the beginning of the zone; specifies that a school zone is in effect 60 minutes before school starts, 60 minutes after school starts, 60 minutes before school ends, and 60 minutes after school ends.
