Proposed law provides for changes to the regulation of boilers under the jurisdiction of the State Fire Marshal. Proposed law expands and clarifies the authority of the Fire Marshal with respect to rulemaking, inspection standards, and the licensing of boiler inspectors. Proposed law expands authority of the State Fire Marshal to establish or adjust fees for inspections, licensing, and related regulatory activities. Proposed law provides for an effective date of January 1, 2027.

EXPENDITURE EXPLANATION
 There is no anticipated direct material effect on governmental expenditures as a result of this measure.

REVENUE EXPLANATION
 Proposed law will result in an increase in SGR for the Office of the State Fire Marshal (OSFM) through fees associated with licensing of inspectors, boiler inspections, and enforcement activities. Proposed law revises fees and enforcement provisions associated with boiler regulation under the OSFM. The measure establishes a uniform fee structure and increases multiple existing fees. The Department of Public Safety, Office of State Fire Marshal (OSFM), reports the proposed law would result in a total increase in self-generated revenue of \$815,290.
