10 **other states with regard to psychedelic assisted therapy and related drug development."**

12 On page 3, line 7, after "appropriate" insert "trial"

13 AMENDMENT NO. 6

14 On page 4, between lines 21 and 22, insert the following:

15 **"(3) To the extent feasible, the Louisiana Department of Health shall support**
16 **and encourage the use of opioid settlement funds and other related monies as matching**
17 **funds for federal or other external funding opportunities in support of Louisiana trial**
18 **and trial-enabling studies."**
