Amendments proposed by Senate Committee on Judiciary B to Engrossed House Bill No. 985 by Representative Dickerson

1 AMENDMENT NO. 1

2 On page 1, line 2, change "R.S. 32:412(I) and R.S. 40:1321(J)" to "R.S. 32:412(I)(1), (2),
3 (4), and (5) and R.S. 40:1321(J) and to enact R.S. 32:412(I)(6)"

4 AMENDMENT NO. 2

5 On page 1, line 7, after "Section 1." delete R.S. 32:412(I) is hereby amended and reenacted"
6 and insert: "R.S. 32:412(I)(1), (2), (4), and (5) are hereby amended and reenacted and R.S.
7 32:412(I)(6) is hereby enacted"

8 AMENDMENT NO. 3

9 On page 2, delete lines 5 through 8 and insert the following:

11 AMENDMENT NO. 4

12 On page 2, line 10, after "license", delete the remainder of the line and delete lines 11 and
13 12 and insert "every year, in addition to the yearly reregistration pursuant to R.S. 15:542 et
14 seq."

15 AMENDMENT NO. 5

16 On page 2, line 19, after "license." delete the remainder of the line

17 AMENDMENT NO. 6

18 On page 2, at the beginning of line 20, before "office of" change "the" to "The"

19 AMENDMENT NO. 7

20 On page 2, line 26, after "conviction." and before "A" insert "This Subsection shall not apply
21 to any registered sex offender who possesses a special identification card pursuant to R.S.
22 40:1321(J)."

23 AMENDMENT NO. 8

24 On page 2, at the end of line 29, insert "Any registered sex offender who has both a driver's
25 license and a special identification card shall have a quick response code or QR code on his
26 driver's license and special identification card, as required by this Subsection."

27 AMENDMENT NO. 9

28 On page 3, delete lines 15 through 17, at the beginning of line 18, delete "and the" and insert
29 the following:

30 "This special identification card shall include the words "sex offender" in all
31 capital letters which are orange in color and shall be valid for a period of one year
32 from the date of issuance. This special identification card shall be carried on the
33 person The holder shall carry the special identification card on his person at all times
34 by"

1 AMENDMENT NO. 10

2 On page 3, delete line 22 and insert "Subsection shall personally appear, ~~annually~~, at a field
3 office of "

4 AMENDMENT NO. 11

5 On page 3, delete line 23 and insert "the office of motor vehicles to ~~renew~~ obtain his ~~or her~~
6 special identification card ~~but only~~"

7 AMENDMENT NO. 12

8 On page 4, line 3, after "issue" delete "or renew"

9 AMENDMENT NO. 13

10 On page 4, line 6, change "This" to "Except as provided in Paragraph (5) of this Subsection,
11 this"

12 AMENDMENT NO. 14

13 On page 4, line 13, after "(5)" and before "A" insert "The provisions of this Subsection do
14 not apply to any registered sex offender who possesses a driver's license pursuant to R.S.
15 32:412(D)."

16 AMENDMENT NO. 15

17 On page 4, at the end of line 16, insert "Any registered sex offender who has both a driver's
18 license and a special identification card shall have a quick response code or QR code on his
19 driver's license and special identification card, as required by this Subsection."
