Provides for electronic communication and notification at the Department of Environmental Quality in certain situations. (8/1/26)

Present law provides that the Department of Environmental Quality (DEQ) shall submit all official business using mail or certified mail. Proposed law allows DEQ to send and receive official documentation electronically via email. Official documentation includes: permit applications, variance requests, enforcement policies, notices of violations, notices of determinations, approval of voluntary remedial action plans, notices to committees, and notices to legislators.

**EXPENDITURE EXPLANATION**

Proposed law may decrease SGR expenditures primarily out of the Environmental Trust Dedicated Fund Account, but may include other SGR fund accounts. Proposed law allows the Department of Environmental Quality (DEQ) to send and receive official documentation electronically via email. DEQ reports that in FY 25, the department spent \$170,025 on postage and mailing expenses. This does not include the cost of supplies or the cost to print the document. To the extent DEQ utilizes email, pursuant to the proposed law, there will be a decrease in printing, postage, and mailing expenditures for the department.

DEQ reports that there may be additional technology costs required to implement the proposed law, but at this time is unable to quantify those costs. The department reports that any additional technology upgrades required to implement the proposed law may be partially or wholly offset by the postage savings realized.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
