1 AMENDMENT NO. 1

2 On page 49, line 21, delete "On" and insert "Except as otherwise provided in
3 this Paragraph, on"

4 AMENDMENT NO. 2

5 On page 49, at the beginning of line 22, delete "not coinciding" and insert
6 "which does not coincide"

7 AMENDMENT NO. 3

8 On page 50, line 1, after "E." and before "In" insert "(1)"

9 AMENDMENT NO. 4

10 On page 51, delete lines 6 through 17 and insert the following:

11 ~~"(4) (2) Notwithstanding the provisions of R.S. 18:532.1(A) and (B) or~~
12 ~~any other law to the contrary, the~~ The proposed precinct boundaries submitted
13 to the United States Bureau of the Census by a parish through the secretary of
14 the Senate and the clerk of the House of Representatives or their designees,
15 and approved by the Bureau of the Census as block boundaries for ~~the 1990~~
16 Census each federal decennial census, shall be the precinct boundaries of any
17 for the parish in which the parish governing authority has failed to adopt by
18 ordinance on or before December 31, 1988 a proposal for the establishment or
19 adjustment of precinct boundaries as required by this Section. The precinct
20 boundaries established pursuant to the provisions of this Paragraph shall be
21 effective as provided in R.S. 18:532(E)(2) for reapportionment purposes
22 following each federal decennial census."

23 AMENDMENT NO. 5

24 On page 52, delete lines 5 through 16 and insert the following:

25 "(b) In order to establish block boundaries for the 2000 federal
26 decennial census, proposed precinct consolidations submitted for review
27 through June 30, 1998, in accordance with Subsection C of this Section, shall
28 not be subject to the requirement that the precincts or parts of the precincts
29 shall be in the same state, local, and municipal office voting district and shall
30 not be subject to the provisions of Paragraph C(3) of this Section; provided
31 that any consolidation accomplished pursuant to the provisions of this

1 Subparagraph shall be effective for the following purposes at the following
2 times:

3 (i) Not later than January 1, 2000, for the purpose of establishing block
4 boundaries for the 2000 federal decennial census and for reapportionment

6 (ii) Not later than December 31, 2001, for all purposes.

7 (c) The provisions of Subparagraph (b) of this Paragraph shall not
8 apply to consolidations required by R.S. 18:532(B)(4)."

9 AMENDMENT NO. 6

10 On page 54, delete lines 10 and 11 and insert the following:

11 ~~D. In accordance with R.S. 18:1903, on and after January 1, 1989,~~
12 ~~Notwithstanding any other law to the contrary, no election"~~

13 AMENDMENT NO. 7

14 On page 54, line 15, change "two" to "three"

15 AMENDMENT NO. 8

16 On page 54, at the end of line 16 delete the colon ":" and delete lines 17
17 through 25 and on page 55, delete lines 1 through 12 and insert the following:

18 "precincts shall be consolidated as required by R.S. 18:532(B)(4) after January
19 1, 2002, provided that no such consolidation shall cause a precinct to be in
20 more than one state, local, or municipal office voting district as reapportioned
21 following the 2000 federal decennial census."
