PURPOSE OF BILL:

INDIAN AFFAIRS. Recognizes Four Winds Tribe, Louisiana Cherokee Confederacy as an Indian tribe and memorializes the Congress of the United States to do the same.

State recognition of an Indian tribe does not obligate the state to expend any funds; however, the federal Bureau of Indian Affairs requires State recognition in order for an Indian tribe to receive federal recognition. Federal recognition for an Indian tribe is a vigorous process, and State recognition is one of many requirements in the process. Federal recognition is required in order for an Indian tribe to receive land grants and operate casinos.
