Provides for unladen lift equipment to tow a vehicle

Proposed legislation allows current annual noncritical off-road equipment permit holders the ability to tow a two-axle vehicle as long as the towed vehicle does not exceed 10,000 pounds gross vehicle weight and the equipment and the towed vehicle does not exceed an overall length of 65 feet.


