2	To urge and request the Board of Regents, the Department of Revenue, and the Louisiana
3	Workforce Commission to work cooperatively relative to the reporting and sharing
4	of certain information and data, including but not limited to information and data
5	related to the success of Louisiana's postsecondary graduates in the workforce, and
6	to submit jointly a written report of progress relative to such cooperation and any
7	recommendations for related legislation to the House Committee on Education and
8	the Senate Committee on Education not later than sixty days prior to the beginning
9	of the 2011 Regular Session of the Legislature of Louisiana.
10	WHEREAS, there is concern that some students are graduating from public
11	postsecondary education institutions in Louisiana without the skills or knowledge to
12	successfully enter the workforce; and
13	WHEREAS, having a professional and highly skilled workforce is critical to the
14	overall success of the state; and
15	WHEREAS, coordination and collaboration on data related to the success of
16	graduates in the workforce would aid public postsecondary institutions in improving their
17	overall effectiveness and efficiency and would be a positive step toward improving
18	educational and employment outcomes in the state of Louisiana.
19	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
20	urge and request the Board of Regents, the Department of Revenue, and the Louisiana
