2 To enact R.S. 13:2575.4, relative to ordinance violations in West Baton Rouge Parish; to 3 provide for administrative adjudications; to provide for definitions; to provide for 4 violations subject to administrative adjudication procedures; and to provide for 5 related matters. In the parish of West Baton Rouge, the terms "housing violation" and 14 "environmental violation" as used in this Chapter shall also encompass parish 15 ordinances relative to building codes, zoning, vegetation, abandoned vehicles and 16 junk, garbage, trash, and refuse, livestock keeping, required addresses for E911 17 identification, and nuisances. 18 B. In the parish of West Baton Rouge, the procedures for administrative adjudication provided for in this Chapter may also be used in matters involving 19

Abstract: Provides for administrative adjudication of certain ordinance violations in West Baton Rouge Parish.

<u>Present law</u> (R.S. 13:2575) authorizes municipalities and parishes to prescribe civil fines for violations of certain types of ordinances. Further authorizes any municipality or parish to establish an administrative adjudication hearing procedure, as outlined in <u>present law</u>, to handle such violations. <u>Proposed law</u> retains <u>present law</u>.

<u>Proposed law</u> (R.S. 13:2575.4) provides that in West Baton Rouge Parish the administrative adjudication hearing procedure authorized in <u>present law</u> may also be used for certain other West Baton Rouge Parish ordinance violations, including garbage, trash, and refuse, abandoned vehicles and junk, and nuisance ordinances.

<u>Proposed law</u> further authorizes <u>present law</u> administrative adjudication hearing procedure to be used in licensing, permits, or any ordinance violations as determined by the parish governing authority.
