PUBLIC LANDS/STATE: Authorizes the lease of certain water bottoms and reclaimed lands in Jefferson Parish

AN ACT

2 To authorize and provide for the lease of certain state property; to authorize the lease of 3 certain water bottoms and reclaimed lands in Jefferson Parish; to provide for 4 reservation of mineral rights; to provide for terms and conditions; to provide for an 5 effective date; and to provide for related matters. 6 Be it enacted by the Legislature of Louisiana: 7 Section 1. The commissioner of the division of administration, notwithstanding any 8 other provision of law to the contrary, is hereby authorized and empowered to lease any 9 interest, excluding mineral rights, the state may have to all or any portion or part of the bed 10 and bottom of Lake Pontchartrain within Jefferson Parish and contiguous with the city of 11 Kenner, or lands reclaimed therefrom within the geographical territory encompassed by the 12 city of Kenner that is directly adjacent to Lake Pontchartrain or a part thereof, the bed and 13 bottom thereof, or reclaimed lands thereof to the city of Kenner for use for public purposes. 14 Section 2. The commissioner of the division of administration is hereby authorized 15 to enter into such agreements, covenants, conditions, and stipulations and to execute such 16 documents as necessary to properly effectuate any lease, excluding mineral rights, to the 17 property described in Section 1, and as more specifically described in any such agreements 18 entered into and documents executed by and between the commissioner of the division of 19 administration and the city of Kenner, in exchange of consideration proportionate to the 20 appraised value of the lease of such property. Further, such lease shall authorize the city of

Kenner to place improvements in and on the leased property and may assign or sublease

such lease. In the event of such assignment or sublease, the city of Kenner shall supervise

2 its sublessee or assign to ensure that the terms and conditions of the original lease are

observed. Such assignment or sublease shall be only to the highest responsible bidder after

advertisement in accordance with R.S. 41:1213 through 1215.1. Any sublease or assignment

by the city of Kenner for commercial, economic development, or recreational purpose shall

be considered a public purpose.

Section 3. This Act shall become effective upon signature by the governor or, if not

signed by the governor, upon expiration of the time for bills to become law without signature

by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If

vetoed by the governor and subsequently approved by the legislature, this Act shall become

effective on the day following such approval.

Ligi HB No. 58
