Provides relative to the payment of group insurance premiums for retired sheriffs and deputy sheriffs

Purpose of Bill: This measure provides that persons retiring on or after July 1, 2011, must complete 20 years of service at the Assumption Parish Sheriff’s Office and be at least 55 in order to receive payment of insurance premiums (versus retiring with 20 years of service that may include service years completed in a different sheriff's office).

According to Assumption Parish Chief Civil Deputy, this measure may affect future liabilities of the Sheriff’s Office. Currently, there are no existing employees that would have to push back retirement dates as a result of this measure. However, if they hired someone in the future that had seventeen years of service in another agency and the final three years of service with the Assumption Parish Sheriff’s Office, this person would not be eligible for retiree insurance benefits paid for by the Assumption Parish Sheriff’s Office. Therefore, expenditures could be avoided or delayed.
