Provides for the payment of certain insurance premium costs for certain retired assessors and assessors' employees in Catahoula Parish. (8/15/11)

Purpose of Bill: Requires the Catahoula Parish Assessor to pay the premium cost of group life, dental, group health, hospital, surgical, or other medical insurance for any assessor or assessor’s employee who retires with at least 20 years of service and who is at least 55 years old or who retires with at least 30 years of service at any age.
