COASTAL PROTECT/RES AUTH. Approves the FY 2011-2012 annual plan for integrated coastal protection.

A CONCURRENT RESOLUTION 1 2 To approve the fiscal year 2011-2012 annual plan for integrated coastal protection, as adopted by the Coastal Protection and Restoration Authority. 3 WHEREAS, R.S. 49:214.5.1 et seq., provides for the creation, duties, and 4 5 responsibilities of the Coastal Protection and Restoration Authority (authority); and WHEREAS, the powers and duties of the authority include the development of an 6 7 annual state integrated coastal protection plan for protecting, conserving, and restoring the 8 coastal area through the construction and management of hurricane protection and coastal 9 restoration projects and programs, including privately funded marsh management projects 10 or plans, and addressing those activities requiring a coastal use permit which significantly 11 affect such projects; and 12 WHEREAS, as required under the provisions of R.S. 49:214.5.3, the annual state 13 integrated coastal protection plan adopted by the authority must be submitted to the Senate Committee on Natural Resources and the House Committee on Natural Resources and 14 Environment and the Senate Committee on Transportation, Highways and Public Works and 15 16 the House Committee on Transportation, Highways, and Public Works, on or before the fifteenth day of the regular legislative session of each year; and 17 WHEREAS, such committees must take action on the annual state integrated coastal 18

protection plan, and the legislature may approve or disapprove the annual state integrated coastal protection plan by resolution adopted by a majority vote of the members of each house of the legislature; and

WHEREAS, the annual state integrated coastal protection plan shall not be effective or implemented unless both houses of the legislature approve the annual plan, or fail to disapprove the annual state integrated coastal protection plan by July 1, 2011; and

WHEREAS, the authority shall implement the annual state integrated coastal protection plan if the legislature approves the plan or if the legislature fails to timely disapprove of the plan.

THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby approve the fiscal year 2011-2012 annual plan for integrated coastal protection, as adopted by the Coastal Protection and Restoration Authority.

BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the chairman of the Coastal Protection and Restoration Authority.
