2 To enact R.S. 15:255(O), relative to witness fees to off-duty law enforcement officers in the 3 City Court of Crowley; to authorize the city of Crowley to adopt an ordinance to use 4 surplus fees in the fund to equip the police department of the city of Crowley; and 5 to provide for related matters. R.S. 15:255(O) is hereby enacted to read as follows: 11 §255. Witness fees to off-duty law enforcement officers 12 13 O. Notwithstanding any provision of law to the contrary, the city of Crowley 14 may adopt an ordinance which provides that on September first of each year, the 15 amount of money in the witness fee fund provided for the City Court of Crowley which exceeds thirty thousand dollars shall be transferred to the general fund of the 16 17 city of Crowley to be used solely for purchasing equipment for the police department 18 of the city of Crowley. For the purposes of this Subsection, the balance of thirty thousand dollars required to be kept in the witness fee fund shall mean thirty 19 20 thousand dollars in unexpended and unencumbered funds, and under no

Montoucet HB No. 4

Abstract: Provides that monies exceeding \$30,000 in the witness fee fund shall be transferred to the city for payment of equipment for the city of Crowley police department.

<u>Proposed law</u> provides the city of Crowley is authorized to adopt an ordinance which provides that on Sept. 1 of each year, the amount of money in the witness fee fund of the City Court of Crowley which exceeds \$30,000 shall be transferred to the general fund of the city to be used to purchase equipment for the police department.

<u>Proposed law</u> also requires that a balance of \$30,000 shall be kept in the witness fee fund, and under no circumstances shall the balance be reduced to below \$30,000 as a result of a transfer.
