Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana.

TAX/INCOME/PERSONAL. Creates an individual income tax return checkoff for donations to the Louisiana Food Bank Association. (gov sig)

1	AN ACT
2	To enact Subpart BB of Part I of Chapter 1 of Subtitle II of Title 47 of the Louisiana
3	Revised Statutes of 1950, to be comprised of R.S. 47:120.96, relative to state
4	individual income tax return checkoffs for certain donations; to provide for a method
5	for individuals to donate a portion of any refund due to them to the Louisiana Food
6	Bank Association; to provide for the disposition of such donated monies; to establish
7	the Louisiana Food Bank Association Fund as a special escrow fund in the state
8	treasury; to provide for the administration and use of monies in the fund; to authorize
9	the treasurer to make certain deposits into the fund; to provide for an effective date;
10	and to provide for related matters.
11	Be it enacted by the Legislature of Louisiana:
12	Section 1. Subpart BB of Part I of Chapter 1 of Subtitle II of Title 47 of the Louisiana
13	Revised Statutes of 1950, comprised of R.S. 47:120.96, is hereby enacted to read as follows:
14	SUBPART BB. LOUISIANA FOOD BANK ASSOCIATION DONATION
15	§120.96. Income tax checkoff; donation for Louisiana Food Bank Association
16	A. Donation of Refund. Every individual who files an individual income
17	tax return for the current tax year and who is entitled to a refund may designate

1	on his surrout year return that all an any partian of the total amount of the
1	on his current year return that all or any portion of the total amount of the
2	refund to which he is entitled shall be donated to the Louisiana Food Bank
3	Association, in lieu of that amount being paid to him as a refund, in which case
4	the refund shall be reduced by the amount so designated. The designation shall
5	<u>be made at the time of filing the current year tax return and shall be made upon</u>
6	the income tax return form as prescribed by the secretary of the Department
7	of Revenue, hereinafter referred to as the "secretary". No donation made
8	under the provisions of this Part shall be invalid for want of an authentic act.
9	B. There is hereby established in the state treasurer a special escrow
10	fund to be known as the Louisiana Food Bank Association Fund, hereinafter
11	referred to as the "fund". The fund is established to receive deposits of
12	donations made on individual income tax returns for the benefit of the
13	Louisiana Food Bank Association. The fund shall be administered by the
14	<u>treasurer, who shall every sixty days, remit the remaining balance of monies in</u>
15	the fund to the Louisiana Food Bank Association.
16	Section 2. The provisions of this Act shall be applicable to taxable years beginning
17	on or after January 1, 2011.
18	Section 3. This Act shall become effective upon signature by the governor or, if not
19	signed by the governor, upon expiration of the time for bills to become law without signature
20	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
21	vetoed by the governor and subsequently approved by the legislature, this Act shall become
22	effective on the day following such approval.

Peterson (SB 203)

<u>Proposed law</u> provides for an individual income tax checkoff under which an individual can donate a portion of his state income tax refund to the Louisiana Food Bank Association.

<u>Proposed law</u> establishes the Louisiana Food Bank Association Fund as a special escrow fund in the state treasury, which is established to receive deposits related to donations made on tax returns for the benefit of the Louisiana Food Bank Association. The treasurer is

required to remit the remaining balance of monies in the fund to the Louisiana Food Bank Association every 60 days.

Applicable to taxable years beginning on or after Jan. 1, 2011.

Effective upon signature of the governor or lapse of time for gubernatorial action.

Summary of Amendments Adopted by Senate

<u>Committee Amendments Proposed by Senate Committee on Revenue and Fiscal</u> <u>Affairs to the original bill.</u>

- 1. Authorizes the check off for the 2011 tax year.
- 2. Eliminates ability of a taxpayer to donate other money besides a refund to the fund.
- 3. Transfer administration of the fund from the secretary of the Department of Revenue to the treasurer and deletes a provision allowing retaining of money to offset administrative costs.
