HOUSING/AUTHORITIES: Removes the public records exemption that is applicable to affiliates of housing authorities

AN ACT

2	To amend and reenact R.S. 40:487 and R.S. 44:1(A)(1), relative to affiliates of housing
3	authorities; to remove the public records exception applicable to such affiliates; to
4	provide for the applicability of the Public Records Law to such affiliates; to provide
5	relative to applicability to persons holding an ownership interest in or authority over
6	an affiliate of a housing authority; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 40:487 is hereby amended and reenacted to read as follows:
9	§487. Affiliates, applicability of certain laws
10	A. Affiliates of housing authorities shall not, by virtue of their affiliation
11	with such local housing authorities, become subject to the laws of this state
12	applicable to public agencies and their governing bodies, including but not limited
13	to laws pertaining to public disclosure of records, open meetings, minimum wage
14	rates applicable to government contracts and employees, if any, procurement of
15	goods and services, and laws relating to public employees.
16	B. Notwithstanding any provision of Subsection A of this Section to the
17	contrary, affiliates of housing authorities shall be subject to the Public Records Law.
18	For the purposes of the Public Records Law, affiliates of housing authorities shall be
19	considered public bodies.

1	Section 2. R.S. 44:1(A)(1) is hereby amended and reenacted to read as follows:
2	§1. General definitions
3	A.(1) As used in this Chapter, the phrase "public body" means any branch
4	department, office, agency, board, commission, district, governing authority
5	political subdivision, or any committee, subcommittee, advisory board, or task force
6	thereof, or any other instrumentality of state, parish, or municipal government
7	including a public or quasi-public nonprofit corporation designated as an entity to
8	perform a governmental or proprietary function, or an affiliate of a housing
9	authority.

11	Section 2. Nothing in this Act shall be construed to require the disclosure of any
12	document or record of a person who holds an ownership interest in or authority over an
13	affiliate of a housing authority and who is not otherwise subject to the Public Records Law
14	however, nothing in this Section shall be construed to prevent the disclosure of the identity

Hardy HB No. 188

Abstract: Makes housing authority affiliates subject to the Public Records Law.

<u>Present law</u> (R.S. 40:384) defines an "affiliate" of a housing authority as any corporation, entity, partnership, venture, syndicate, or arrangement in which a local housing authority has an ownership or governance interest of less than a majority.

<u>Present law</u> (R.S. 40:487) provides that affiliates of housing authorities are not subject to the laws of the state applicable to public agencies and their governing bodies by virtue of their affiliation with a local housing authority. <u>Proposed law</u> retains <u>present law</u> except that <u>proposed law</u> provides for the applicability of the Public Records Law to such housing authority affiliates.

<u>Present law</u> (R.S. 44:1) provides a definition of the term "public body" as it is used in the Public Records Law. <u>Proposed law</u> retains <u>present law</u> and adds affiliates of housing authorities to such definition.

<u>Proposed law</u> further provides that <u>proposed law</u> shall not require the disclosure of documents or records of persons who hold an ownership interest in, or authority over, an

affiliate of a housing authority. Further provides that such protection shall not prevent the disclosure of the identity of persons holding an ownership interest in an affiliate.

Committee Amendments Proposed by <u>House Committee on House and Governmental</u> <u>Affairs</u> to the <u>original</u> bill.

- 1. Deletes language relative to employees of affiliates being considered public employees for the purposes of the Public Records Law.
- 2. Adds provision regarding individuals and entities having an ownership interest in, or authority over, an affiliate.
