13	to fill the position of another classroom teacher who is unavailable to teach for any
14	reason. Such substitute classroom teacher's earnings from his return to active service
15	shall not exceed twenty-five percent of his benefit during any fiscal year. If actual
16	earnings exceed this amount in any fiscal year, the benefits payable to the retiree
17	shall be reduced by the amount in excess of twenty-five percent of his benefit."

(2) Any retired member not considered a retired teacher as defined in Subsection A of this Section shall have his benefit suspended for the duration of his period of reemployment in such position <u>even if such reemployment is based on</u> <u>employment by contract or corporate contract</u>. Such member and his employer shall not make contributions to the system during such time, and he shall receive no additional service credit nor accrue any additional retirement benefits.
