Provides for the membership, powers, and duties of the Ground Water Management Advisory Task Force. (8/15/11)

<u>Present law</u> provides for the membership of the Ground Water Management Advisory Task Force, for the powers and duties of the task force, and for the meeting requirements of the task force.

<u>Proposed law</u> changes the membership and meeting requirements of the task force. Provides that fifteen members of the task force shall constitute a quorum and that the task force shall meet at least once per year, or more frequently as necessary.

Repeals Section 4 of Act 446 of the 2001 Regular Session of the Legislature and Section 5 of Act 49 of the 2003 Regular Session of the Legislature.

EXPENDITURE EXPLANATION

In addition, the legislation reduces the number of meetings that are required from quarterly to annually by the task force.

The repealed sections of Act 446 of the 2001 Regular Legislative Session and Act 49 of the 2003 Regular Session of the Legislature provided for membership of the task force, the duties of the task force and that the task force shall meet at least once per quarter. Although these sections passed the Legislature and signed by the Governor, they were never placed in the Revised Statutes.
