**Subject:** Correctional Facilities

Provides for state correctional facilities. (gov sig)

Proposed legislation requires that all correctional facilities whose operations become subject to a contract with a private prison contractor be accredited by the American Correctional Association (ACA) within 24 months of becoming subject to the contract and maintain accreditation by the ACA at all times thereafter. Effective upon signature of the governor.

## **EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

The cost to become an accredited American Correctional Association (ACA) facility will be paid by the private prison contractor. According to the ACA, the cost of receiving accreditation at a facility is \$3,000 per day plus \$1,500 for each auditor on the audit team (regardless of facility size). Once accredited, a facility remains accredited for 3 years, and then begins the reaccreditation process.

NOTE: All state correctional facilities are ACA accredited.
