SENATE CONCURRENT RESOLUTION NO. 41

HEALTH/HOSPITALS DEPT. Requests that the Department of Health and Hospitals continue its reliance on the Medicaid Purchase Plan Advisory Council for program outreach, education, review, and guidance.

A CONCURRENT RESOLUTION

To urge and request the Department of Health and Hospitals to continue its reliance on the Medicaid Purchase Plan (MPP) Advisory Council for program outreach, education, review and guidance.

WHEREAS, the Ticket to Work and Work Incentives Improvement Act of 1999 (P.L. 106-170) was intended to enhance work incentives for persons with disabilities by changing programs operated by the Social Security Administration, the Department of Labor, and the Department of Health and Human Services; and

WHEREAS, Section 201 of the Ticket to Work and Work Incentives Improvement Act of 1999 created two new optional categorically needy Medicaid eligibility groups to eliminate barriers to employment for individuals with disabilities by improving access to health care; and

WHEREAS, securing and maintaining competitive employment in an integrated setting remains a significant challenge for individuals with disabilities; and

WHEREAS, current statistics show that three out of every four individuals with significant disabilities are not working; and

WHEREAS, one of the major barriers for individuals with disabilities is the fear of losing comprehensive health coverage if they work; and

1 WHEREAS, Louisiana citizens with disabilities represent an untapped and often  
2 skilled labor pool; and

3 WHEREAS, Louisiana has implemented an effective Medicaid Buy-in program,  
4 Medicaid Purchase Plan, which allows enrollees with disabilities to pay a premium and  
5 obtain or retain health care benefits, and allows individuals with disabilities to contribute tax  
6 dollars by returning to the workforce; and

7 WHEREAS, while the MPP Advisory Council has contributed to significant  
8 improvements in Medicaid and other services to support people with disabilities in their  
9 competitive employment efforts, thousands of Louisiana citizens with disabilities who want  
10 to work and pay taxes still remain idle and dependent upon state and federal assistance.

11 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby  
12 urge and request the Department of Health and Hospitals to continue to work with the  
13 Medicaid Purchase Plan Advisory Council, to provide it access to enrollment and utilization  
14 data, and to seek its guidance on health care policy that impacts workers with disabilities.

15 BE IT FURTHER RESOLVED that the MPP Advisory Council be continued in the  
16 absence of funding provided through the state's Medicaid Infrastructure and Competitive  
17 Employment System Grants, with sustainability provided by its members with no direct  
18 funding provided by the state.

19 BE IT FURTHER RESOLVED that the MPP Advisory Council continue to consult  
20 with and assist the department by providing input and guidance, making recommendations,  
21 assisting with Medicaid Purchase Plan outreach and education efforts, and participating in  
22 program review and evaluation, as well as with other health care issues that impact workers  
23 with disabilities.

24 BE IT FURTHER RESOLVED that the MPP Advisory Council continue to meet at  
25 regularly scheduled intervals.

26 BE IT FURTHER RESOLVED that the council be composed of twenty-six members,  
27 representing each of the following:

- 28 (1) Medicaid, director or designee.  
29 (2) Office of Developmental Disabilities, director or designee.  
30 (3) Louisiana Workforce Commission, director or designee.

- 1 (4) Louisiana Rehabilitation Services, director or designee.
- 2 (5) Statewide Independent Living Council, director or designee.
- 3 (6) Louisiana Commission for the Deaf, director or designee.
- 4 (7) Office of Aging and Adult Services, director or designee.
- 5 (8) Office of Behavioral Health, director or designee.
- 6 (9) People First of Louisiana, director or designee.
- 7 (10) Mental Health America of Louisiana, director or designee.
- 8 (11) Families Helping Families, director or designee.
- 9 (12) Advocacy Center, director or designee.
- 10 (13) Louisiana Assistive Technology Assistance Network, director or designee.
- 11 (14) Independence Regained, Inc., director or designee.
- 12 (15) Work Incentives Planning and Assistance.
- 13 (16) Office of Citizens with Developmental Disabilities, director or designee.

Requests DHH to continue to work with the Medicaid Purchase Plan Advisory Council, to provide it access to enrollment and utilization data, and to seek its guidance on health care policy that impacts workers with disabilities. Continues the council in the absence of funding provided through the state's Medicaid Infrastructure and Competitive Employment System Grants, with sustainability provided by its members with no direct funding provided by the state. Provides that the council continue to consult with and assist the department by providing input and guidance, making recommendations, assisting with Medicaid Purchase Plan outreach and education efforts, and participating in program review and evaluation, as well as with other health care issues that impact workers with disabilities. Provides that the council meet at regularly scheduled intervals.

Provides that the council be composed of 26 members, representing each of the following:

- (3) La. Workforce Commission, director or designee.
- (4) La. Rehabilitation Services, director or designee.
- (5) Statewide Independent Living Council, director or designee.

- (7) Office of Aging and Adult Services, director or designee.
- (8) Office of Behavioral Health, director or designee.
- (9) People First of Louisiana, director or designee.
- (10) Mental Health America of Louisiana, director or designee.
- (11) Families Helping Families, director or designee.
- (12) Advocacy Center, director or designee.
- (13) La. Assistive Technology Assistance Network, director or designee.
- (14) Independence Regained Inc., director or designee.
