**SENATE COMMITTEE AMENDMENTS**

Amendments proposed by Senate Committee on Finance to Original Senate Bill No. 213 by Senator Michot

1 AMENDMENT NO. 1

2 On page 1, line 6, after “administration” and before “relative to” insert “and chief  
3 information officer”

4 AMENDMENT NO. 2

5 On page 2, between lines 7 and 8, insert the following:

6 **“(1.1) “CIO” means the chief information officer, head of the office of**  
7 **information technology within the division of administration.”**

8 AMENDMENT NO. 3

9 On page 2, delete lines 16 through 18 and insert the following:

10 **“A. The CIO, under the direction of the commissioner of administration,**  
11 **shall have the following duties relative to the oversight and operation of the**  
12 **state of Louisiana's governmental portal:**  
13 **(1) To provide oversight of the agencies within the division of**  
14 **administration which supply and ensure electronic”**

15 AMENDMENT NO. 4

16 On page 2, delete lines 24 through 27, and insert the following:

17 **“(3) To provide appropriate oversight of any contracts relative to the**  
18 **operation of the state's portal.”**

19 AMENDMENT NO. 5

20 On page 2, line 28, change “(5)” to “(4)”

21 AMENDMENT NO. 6

22 On page 3, line 5, change “(6)” to “(5)”

23 AMENDMENT NO. 7

24 On page 3, line 8, change “(7)” to “(6)”

25 AMENDMENT NO. 8

26 On page 3, delete lines 10 and 11

27 AMENDMENT NO. 9

28 On page 3, line 12, change “**shall**” to “**may**”

29 AMENDMENT NO. 10

30 On page 3, line 15, change “**shall**” to “**may**”

1 AMENDMENT NO. 11

2 On page 3, delete lines 17 through 23 and insert the following:

3 **"D. Nothing in this Subpart shall be construed to affect the availability**  
4 **of public records in accordance with the Public Records Law as provided by**  
5 **R.S. 44:1, et seq.**

6 **E. The commissioner of administration shall recommend any value-**  
7 **added charges for transactions or classes of transactions conducted through the**  
8 **portal for the review and approval of the Joint Legislative Committee on the**  
9 **Budget.**

10 **F. Nothing herein shall apply to postsecondary education institution**  
11 **portals used to support faculty and students, nor to the Louisiana State**  
12 **University Health Electronic Health Record program established to provide**  
13 **patients and their treating medical team with access to patient medical**  
14 **information."**

15 AMENDMENT NO. 12

16 On page 3, line 25, change "commissioner of administration shall use" to "CIO, under  
17 the direction of the commissioner of administration, shall oversee"

18 AMENDMENT NO. 13

19 On page 4, at the beginning of line 20, change "(7) Primarily fund" to "(7) Fund"
