HOUSE CONCURRENT RESOLUTION NO. 129

BY REPRESENTATIVE MICHAEL JACKSON

HIGHER ED/BD REGENTS: Directs Board of Regents to restore funding of LOUIS to at least the percentage provided for in FY 2009-2010 and expresses support for LOUIS as a critical component of the success of public postsecondary education institutions

A CONCURRENT RESOLUTION

2	To direct the Board of Regents to restore its funding of LOUIS, the Louisiana Library
3	Network, to at least the percentage provided for in Fiscal Year 2009-2010 and to
4	express support for LOUIS as a critical component of the success of the state's public
5	postsecondary education institutions.
6	WHEREAS, LOUIS, the Louisiana Library Network, provides essential information,
7	resources, and services to the public postsecondary education institutions of the state; and
8	WHEREAS, in 1992, LOUIS was formed in response to shrinking library funding
9	in the effort to equalize technology and resources in academic libraries across the state, and
10	since then, LOUIS has contributed significantly to the success of the state's public
11	postsecondary education institutions as well as museums and archives; and
12	WHEREAS, LOUIS provides around-the-clock technology and enterprise solutions
13	to students, faculty, and staff so that scholarly materials can be purchased, identified,
14	searched, and shared; and
15	WHEREAS, the essential resources and services that LOUIS offers include the
16	library automation system and catalogs of library collections, electronic research databases
17	and full-text journals, remote access to library resources twenty-four hours a day,
18	interlibrary loan and reciprocal borrowing among all member libraries, and the Louisiana
19	Digital Library, as well as centralized servers and an expert support staff; and

1	WHEREAS, LOUIS, a proven model of how to collaborate and consolidate, reduces
2	duplication and saves the state millions of dollars annually; and
3	WHEREAS, LOUIS purchased more than nineteen million dollars worth of resources
4	for member libraries in 2010 for only three million one hundred thousand dollars,
5	representing a huge savings to each campus and to the state; and
6	WHEREAS, in the past, the Board of Regents has provided seventy percent of the
7	funding for LOUIS, with member institutions contributing the remaining thirty percent, a
8	feasible amount for all; and
9	WHEREAS, LOUIS funding is uncertain for 2011, and member institutions may not
10	have the funds to cover an increased share of this funding, especially in the face of current
11	dramatic budget cuts, thus putting in peril essential library resources and services across the
12	state; and
13	WHEREAS, LOUIS is essential to the functions of each of the state's public
14	postsecondary education institutions, because without it, students would no longer be able
15	to conduct the research for much of their course work, and faculty would no longer have
16	access to many of the resources they need to continue to produce quality research in their
17	fields; and
18	WHEREAS, without LOUIS, Louisiana's public postsecondary education institutions
19	would have trouble meeting certain Southern Association of Colleges and Schools (SACS)
20	core requirements and comprehensive standards, and the loss of SACS accreditation would
21	negatively affect an institution's ability to award degrees and students' ability to receive
22	financial aid and could also have a detrimental impact on its National Collegiate Athletic
23	Association accreditation; and
24	WHEREAS, the importance of LOUIS to Louisiana's public postsecondary education
25	institutions cannot be overstated, and it is critical that it remain an available resource for the
26	state's higher education community.
27	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
28	direct the Board of Regents to restore its funding of LOUIS, the Louisiana Library Network,
29	to at least the percentage provided for in Fiscal Year 2009-2010 and does hereby express

- 1 support for LOUIS as a critical component of the success of the state's public postsecondary
- 2 education institutions.
