Page 1 of 1 Constitutional Amendment to provide exclusive authority to Board of Supervisors for Community and Technical Colleges over programs of public postsecondary vocational-technical training and institutions of higher education offering associate degrees Proposed constitutional amendment removes the requirement that the Board of Supervisors of the Louisiana Community and Technical College System supervise and manage its programs and institutions subject to the powers vested in the Board of Regents. Requires the Board of Supervisors to meet at least twice a year with the State Board of Elementary and Secondary Education to coordinate programs of public elementary, secondary, vocational-technical, career and higher education. Specifies the powers, duties, and responsibilities of the Board of Supervisors as distinct from those of the Board of Regents as it relates to community or technical colleges and institutions limited to offering lower rank degrees compared to those authorized to offer baccalaureate degrees.
