TRANSPORTATION/DEV DEPT. Creates Task Force on the Crescent City Connection to analyze re-authorization of tolls, ferry services, and all components and management of the operation of the Crescent City Connection Division of the Department of Transportation and Development.

| 6  | WHEREAS, tolls imposed upon the Crescent City Connection Bridge crossing the              |
| 7  | Mississippi River at New Orleans, Louisiana, expire on December 31, 2012, as provided in  |
| 8  | R.S. 47:820.5; and  |
| 9  | WHEREAS, numerous westbank civic and business leadership organizations have               |
| 10 | formed a "Regional Collaborative" and have requested creation of a task force to formally |
| 11 | evaluate the future of the Crescent City Connection Division, tolls, ferry service,       |
| 12 | governance, and all related aspects of the Crescent City Connection Division's future     |
| 13 | operations; and   |
| 14 | WHEREAS, such "Regional Collaborative" recognizes that the anticipated changes            |
| 15 | to the Crescent City Connection Division of the Department of Transportation and          |
| 16 | Development will have a significant impact upon the business and civic communities in the |
| 17 | greater New Orleans region.   |
| 18 | THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby                   |

1 create the Task Force on the Crescent City Connection to be composed of eleven persons 2 who shall serve without compensation from the task force. 3 BE IT FURTHER RESOLVED that each of the following organizations shall 4 collaborate and shall submit a list of two names each to the governor, from which the governor shall select ten persons to serve as members of the task force as follows: 5 (1) One member representing business interests from names submitted by the 6 7 Algiers Economic Development Foundation. 8 (2) One member representing business interests from names submitted by the 9 Harvey Canal Industrial Association. 10 (3) One member representing business interests from names submitted by the 11 Jefferson Chamber of Commerce. 12 (4) One member representing business interests from names submitted by the 13 Plaquemines Association of Business and Industry. 14 (5) One member representing civic interests from names submitted by the Westbank 15 Redevelopment Corporation, Inc., and the Algiers Neighborhood President's Council. 16 (6) One member representing civic interests from names submitted by the West Jefferson Civic Association and The Terrytown Civic Association, Inc. 17 18 (7) One member representing maritime interests from names submitted by the Port 19 of New Orleans, the Plaquemines Port, Harbor and Terminal District, the Jefferson Parish 20 Economic Development and Port District, and the St. Bernard Port, Harbor and Terminal 21 District. (8) One member who is a professional engineer from names submitted by the 22 23 Regional Planning Commission. (9) One member from names submitted by Friends of the Ferry of New Orleans. 24 25 (10) One member with experience in law enforcement from names submitted by the New Orleans Police Department, the Jefferson Parish Sheriff's Office, the Gretna Police 26 27 Department, the Westwego Police Department, and the Plaquemines Parish Sheriff's Office. BE IT FURTHER RESOLVED that the lists of names shall be submitted to the 28 29 governor no later than July 1, 2011, and if a list is not timely submitted, the governor shall 30 make the selections at large.

| 7        | BE IT FURTHER RESOLVED that the initial meeting of the task force shall be   |
| 8        | convened no later than August 1, 2011, by the secretary of the Department of Transportation  |
| 9        | and Development at the offices of the Crescent City Connection Division in New Orleans,  |
| 10       | Louisiana.   |
| 11       | BE IT FURTHER RESOLVED that at the initial meeting, the members of the task  |
| 12       | force shall provide for the manner and frequency of meetings that will be conducted and for  |
| 13       | all other ancillary administrative matters which must be determined in order to function as  |
| 14       | a task force. Meetings of the task force shall be held at the offices of the Crescent City   |
| 15       | Connection Division. The task force shall be staffed by the Department of Transportation   |
| 16       | and Development.   |
| 17       | BE IT FURTHER RESOLVED that the task force shall have unrestricted access to   |
| 18       | all records and information relevant to its mission and maintained by the Department of  |
| 19       | Transportation and Development and the Crescent City Connection Division and that the  |
| 20       | secretary of the Department of Transportation and Development or her designee shall fully  |
| 21       | cooperate with and provide records and information to the task force.  |
| 22       | BE IT FURTHER RESOLVED that the task force is authorized and directed to study,  |
| 23       | evaluate, analyze, and review all aspects of the operation of the Crescent City Connection   |

# Committee Amendments Proposed by Senate Committee on Transportation, Highways, and Public Works to the original Concurrent Resolution.

- 1. Increases size of task force <u>from 9 to 11</u>, allowing Harvey Canal Industrial Association and the Jefferson Chamber of Commerce to have separate members and adding the secretary of DOTD as a member.
- 2. Provides that secretary of DOTD shall act as chair of task force.
