LAW ENFORCEMENT Provides for the training of all chiefs of police

Purpose of Bill: This measure requires all non-municipal Chiefs of Police appointed or elected on or after January 1, 2012 to attend training courses and continuing education classes administered by the Law Enforcement Executive Management Institute. This measure shall not apply to the superintendent of the Louisiana State Police, sheriffs and constables.

EXPENDITURE EXPLANATION

State General Fund expenditures are anticipated to increase as a result of this measure.

According to an official with the Louisiana Commission on Law Enforcement, an estimated 40 additional police chiefs will be required to attend training. This estimate includes 34 campus police chiefs, 3 harbor police chiefs, and 3 police chiefs of Indian tribes.

The estimated cost to train these chiefs for the first year is approximately \$50,000. Costs of training may vary since the number of non-municipal chiefs of police impacted by this bill has not been officially determined.

The official also stated that future continuing education training will be required biannually at an undetermined cost.
