A CONCURRENT RESOLUTION

2	To urge and request that the State Board of Elementary and Secondary Education work in
3	collaboration with the State Library of Louisiana and LOUIS: The Louisiana Library
4	Network to ensure the funding of library research databases and to negotiate the most
5	advantageous prices for school libraries in Louisiana.
6	WHEREAS, libraries play an essential role in a free and democratic society,
7	improving the quality of life of citizens throughout the state and contributing to the learning
8	environment at every level of education; and
9	WHEREAS, use of libraries is strong even in the age of the Internet, as forty-three
10	percent of Louisiana households do not have Internet access and rely on libraries for such
11	access; and
12	WHEREAS, fostering literacy and lifelong learning is still the foundation of library
13	programs, but the definition of literacy has expanded to encompass twenty-first century
14	literacy skills, including the ability to use computer-based and online resources effectively;
15	and
16	WHEREAS, school libraries are many citizens' first introduction to the library
17	learning experience and are where many individuals are first provided instruction in basic
18	computer literacy, Internet search skills, and library database use; and

1 WHEREAS, school libraries can more effectively foster lifelong learning for all 2 citizens of Louisiana by providing access to a broad range of online library databases, which 3 are edited, validated resources providing access to reliable and authoritative information; and 4 WHEREAS, online library databases have become core resources that all school libraries need to meet the information need of students and teachers, and these databases are 5 6 subscription-based services with associated annual costs; and 7 WHEREAS, the most cost-effective means of providing online library databases is 8 through contracts that make them available to all school libraries with the goal of adequately 9 educating Louisiana's citizens and therefore improving the quality of life in Louisiana; and 10 WHEREAS, it is critical that the State Board of Elementary and Secondary 11 Education collaborate with the State Library of Louisiana and LOUIS: The Louisiana 12 Library Network in the effort to maximize educational opportunities for students throughout 13 the state. 14 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 15 urge and request that the State Board of Elementary and Secondary Education work in 16 cooperation with the State Library of Louisiana and LOUIS: The Louisiana Library Network 17 to ensure the funding of library research databases and to negotiate the most advantageous 18 prices for school libraries in Louisiana. 19 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted 20 to the president of the State Board of Elementary and Secondary Education, the state 21 superintendent of education, the state librarian of Louisiana, and the executive director of 22 LOUIS: The Louisiana Library Network.
