11 1, delete line 30 in its entirety and insert "**producer or health and accident insurance**

14 AMENDMENT NO. 13

15 On page 2, line 15, after "**Subsection,**" delete the remainder of the line and at the beginning
16 of line 16, delete "**as**" and insert the following:

17 **"the following terms shall be defined as follows:**
18 **(a) "Claim and claimant identifier" shall mean"**

19 AMENDMENT NO. 14

20 On page 2, after line 18, insert the following:

21 **"(b) "Health and accident insurance issuer" shall mean any entity that**
22 **offers health and accident insurance coverage through a policy or certificate of**
23 **insurance subject to state law that regulates the business of insurance. For**
24 **purposes of this Subsection, a "health and accident insurance issuer" shall**
25 **include a health maintenance organization as defined and licensed pursuant to**
26 **Subpart I of Chapter 2 of this Title.**

27 **(c) "Policy" shall mean a health and accident insurance policy or a**
28 **health maintenance organization contract.**

29 **(d) "Policyholder" shall mean the holder of a health and accident policy,**
30 **a health maintenance organization contract holder, an insured, a subscriber, or**
31 **an enrollee.**

32 **(5) The provisions of this Subsection shall not apply to dental insurance."**
