## **EXPENDITURE EXPLANATION**

LOUIS was funded in FY 2009-2010 by Board of Regents at 67% of their total funding of \$4,085,971. The FY12 budget for the Board of Regents includes \$500,000 or 14% of total for LOUIS with the balance of LOUIS' operating funds currently being charged to the campuses that participate in the LOUIS library network. <u>In order to bring FY 2011-2012 funding up to the</u> 67% level of FY 2009-2010, an additional \$2,237,601 would be needed from state general fund. Expenditures for subsequent fiscal years have not been projected, but the assumption would be an increase each year based on trends of subscription costs. Expenditures from agency self-generated funds will also decrease by \$2,237,601 each year because LOUIS library member fees will decrease due to the increase in state general funds.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
