### SENATE BILL NO. 93

2	To amend and reenact R.S. 37:1026.1 and 1026.6(B)(10) and to enact Part XLII of Chapter
3	5 of Title 40 of the Louisiana Revised Statutes of 1950, to be comprised of R.S.
4	40:1300.21 through 1300.22, and to repeal R.S. 37:1026.9, relative to training
5	programs for certified nurse aides; to provide for the medication attendant
6	certification program for certified nurse aides; to provide for a clinical preceptor
7	nurse aide training program maintained by the Louisiana Community and Technical
8	College System for certified nurse aides; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. R.S. 37:1026.1 and 1026.6(B)(10) are hereby amended and reenacted to
11	read as follows:
12	§1026.1. Purpose
13	The purpose of this Part is to create a pilot program that shall authorize
14	certification of medication attendants to perform certain functions in licensed nursing
15	homes until August 1, 2011. This program shall be administered by the Department
16	of Health and Hospitals.

18	§1026.6. Promulgation of rules and regulations

20	B. The rules and regulations shall include but not be limited to:

22	(10) Preparation and delivery of annual interim reports to the Senate
23	Committee on Health and Welfare and the House Committee on Health and Welfare
24	not less than thirty days prior to the commencement of the regular session of the
25	legislature and a final report to same not later than January 31, 2011 for purposes
26	of performance evaluation and continuance.

2	PART XLII. CLINICAL PRECEPTOR NURSE AIDE TRAINING PROGRAM
3	§1300.21. Clinical preceptor nurse aide training program; legislative intent
4	The Legislature of Louisiana hereby finds that there is a serious need for
5	adequately trained certified nurse aides and, therefore, it is in the best interest
6	of the state to maximize the opportunities which are available to students who
7	are seeking to become certified nurse aides. The legislature further finds that
8	a clinical preceptor nurse aide training program operated by the Louisiana
9	Technical and Community College System in conjunction with nursing homes
10	located throughout the state not only provides a viable method of training but
11	also provides such training at a considerably lower cost than the traditional
12	method of training.
13	<u>§1300.22. Clinical preceptor training program</u>
14	A. The Louisiana Community and Technical College System is hereby
15	authorized to develop and maintain a clinical preceptor nurse aide training
16	program.
17	<b>B.</b> Any program developed under the provisions of this Part shall be in
18	compliance with all federal laws and regulations.
19	Section 3. R.S. 37:1026.9 is hereby repealed.
