1    AMENDMENT NO. 1

2    On page 1, line 2, change "98.3(A)," to "98.3(A) and (B),"

3    AMENDMENT NO. 2

4    On page 1, line 11, change "98.3(A)" to "98.3(A) and (B)"

5    AMENDMENT NO. 3

6    On page 1, line 8, after "Fund" and before the semicolon ";" insert "and the Health  
7    Excellence Fund; to provide for appropriations from the Health Excellence Fund"

8    AMENDMENT NO. 4

9    On page 1, at the beginning of line 9, change "fund;" to "funds;"

10   AMENDMENT NO. 5

11   On page 2, delete lines 25 through 28 and insert the following:

12                    **"(2) Beginning Fiscal Year 2011-2012, and each fiscal year thereafter, the**  
13                    **treasurer shall credit to the Health Excellence Fund fifty percent of the**  
14                    **Settlement Agreement proceeds deposited into the Millennium Trust, and one-**  
15                    **third of all investment earnings on the investment of the Millennium Trust.**

16                    **(3) Upon the effective date of this Section, the state treasurer shall**  
17                    **deposit, transfer, or otherwise credit funds in an amount equal to fifty percent**  
18                    **of such Settlement Agreement proceeds received by the state between April 1,**  
19                    **2011, and the effective date of this Section to the Health Excellence Fund."**

20   AMENDMENT NO. 6

21   On page 3, line 16, change "**one hundred**" to "**fifty**"

22   AMENDMENT NO. 7

23   On page 3, at the end of line 21, after "**equal to**" and before "**such**" insert "**fifty percent of**"

24   AMENDMENT NO. 8

25   On page 3, line 28, delete "the Health Excellence Fund **and**"

26   AMENDMENT NO. 9

27   On page 5, between lines 12 and 13, insert the following:

1 "B. Appropriations from the Health Excellence Fund shall be restricted to  
 2 the following purposes:

4 (4) For Fiscal Year 2011-2012, the Settlement Agreement proceeds  
 5 credited to and deposited into the Health Excellence Fund as provided by  
 6 Paragraphs (B)(2) and (3) of this Section shall be appropriated for additional  
 7 funding of the Children's Health Insurance Program, also known as LaCHIP.  
 8 No amount appropriated as required herein shall displace, replace, or supplant  
 9 appropriations from the general fund for the purposes specified. This  
 10 Paragraph shall mean that no appropriation for any fiscal year from the Health  
 11 Excellence Fund shall be made for such purpose for which a general fund  
 12 appropriation was made in the previous year unless the total appropriations for  
 13 the fiscal year from the state general fund for such purpose exceeds general  
 14 fund appropriations of the previous year.

15 (5) For Fiscal Year 2012-2013 and each fiscal year thereafter, the  
 16 Settlement Agreement proceeds credited to and deposited into the Health  
 17 Excellence Fund as provided by Paragraph (B)(2) of this Section shall be  
 18 appropriated for additional funding of the Children's Health Insurance  
 19 Program, also known as LaCHIP. No amount appropriated as required herein  
 20 shall displace, replace, or supplant appropriations from the general fund for the  
 21 purposes specified. This Paragraph shall mean that no appropriation for any  
 22 fiscal year from the Health Excellence Fund shall be made for such purpose for  
 23 which a general fund appropriation was made in the previous year unless the  
 24 total appropriations for the fiscal year from the state general fund for such  
 25 purpose exceeds general fund appropriations of the previous year."
