12	"(b) Beginning Fiscal Year 2011-2012, and each fiscal year thereafter,
13	the treasurer shall credit to the Health Excellence Fund fifty percent of the
14	Settlement Agreement proceeds deposited into the Millennium Trust, and one-
15	third of all investment earnings on the investment of the Millennium Trust. The
16	<u>treasurer shall report annually to the legislature as to the amount of Millennium</u>
17	Trust Settlement Agreement proceeds and investment earnings credited to the
18	Health Excellence Fund.
19	(c) Upon the effective date of this Subsubparagraph, the state treasurer
20	shall deposit, transfer, or otherwise credit funds in an amount equal to fifty
21	percent of such Settlement Agreement proceeds received by the state between
22	April 1, 2011 and the effective date of this Subsubparagraph to the Health
23	Excellence Fund."

 31 the following purposes:

(d)(i) For Fiscal Year 2011-2012, the Settlement Agreement proceeds credited to and deposited into the Health Excellence Fund as provided by Subsubparagraphs (A)(2)(b) and (c) of this Section shall be appropriated for additional funding of the Children's Health Insurance Program, also known as LaCHIP. No amount appropriated as required herein shall displace, replace, or supplant appropriations from the general fund for the purposes specified. This Subsubparagraph shall mean that no appropriation for any fiscal year from the Health Excellence Fund shall be made for such purpose for which a general fund appropriation was made in the previous year unless the total appropriations for the fiscal year from the state general fund for such purpose exceeds general fund appropriations of the previous year.

(ii) For Fiscal Year 2012-2013 and each fiscal year thereafter, the 13 14 Settlement Agreement proceeds credited to and deposited into the Health 15 Excellence Fund as provided by Subsubparagraph (A)(2)(b) of this Section shall 16 be appropriated for additional funding of the Children's Health Insurance 17 Program, also known as LaCHIP. No amount appropriated as required herein 18 shall displace, replace, or supplant appropriations from the general fund for the 19 purposes specified. This Subsubparagraph shall mean that no appropriation 20 for any fiscal year from the Health Excellence Fund shall be made for such 21 purpose for which a general fund appropriation was made in the previous year unless the total appropriations for the fiscal year from the state general fund for 22 23 such purpose exceeds general fund appropriations of the previous year."
