Prohibits a public entity from purchasing or selling materials which contain certain sexually explicit conduct

Proposed legislation prohibits a public entity from the purchase or sale of materials which contain certain sexually explicit conduct. A violation shall be a misdemeanor and shall be fined not more than \$500 or imprisoned for not more than 6 months, or both.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure. The Office of State Purchasing is unaware of any state agencies that currently purchase such materials.

The proposed legislation is a misdemeanor; therefore, these offenders are not sentenced to the Department of Public Safety and Corrections. Local law enforcement agencies may realize an indeterminable increase in expenditures associated with prison costs. The cost increase will depend on the number of persons convicted and the cost per day for a local law enforcement agency to incarcerate an offender.

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure. To the extent there are violations, any revenues generated from fines would accrue to the local level.
