| 6 | Be it enacted by the Legislature of Louisiana: |
| 7 | Section 1. Subpart O of Part 1 of Chapter 1 of Subtitle II of Title 47 of the Louisiana |
| 8 | Revised Statutes of 1950, comprised of R.S. 47:120.38 is hereby enacted to read as follows: |
| 9 | SUBPART O. LOUISIANA BICENTENNIAL COMMISSION AND |
| 10 | BATTLE OF NEW ORLEANS BICENTENNIAL COMMISSION DONATION |
| 11 | §120.38. Income tax checkoff; donation for Louisiana Bicentennial Commission |
| 12 | and Battle of New Orleans Bicentennial Commission |
| 13 | A. Every individual who files an individual income tax return for the |
| 14 | current tax year and who is entitled to a refund may designate on his current |
| 15 | year return that all or any portion of the total amount of the refund to which he |
| 16 | is entitled shall be donated to the Louisiana Bicentennial Commission, as |
| 17 | provided for in Chapter 27 of Title 25 of the Louisiana Revised Statutes of 1950, |
| 18 | R.S. 25:1231, et seq., and Battle of New Orleans Bicentennial Commission, as |
| 19 | provided for in Chapter 27-A of Title 25, R.S. 25:1238.1, et seq., in lieu of that |
| 20 | amount being paid to him as a refund, in which case the refund shall be reduced |
| 21 | by the amount so designated. The designation shall be made at the time of the |
| 22 | filing of the current year tax return and shall be made on the income tax return |
| 23 | form as prescribed by the secretary of the Department of Revenue. No donation |
| 24 | made under the provisions of this Subsection shall be invalid for lack of an |
| 25 | authentic act. |

| 1 | B.(1) Funds received by the Department of Revenue as provided for in |

| 2 | Subsection B of this Section shall be remitted to Louisiana Historical Legacy |
| 3 | Incorporated, a 501(c)(3) non-profit foundation, registered with the Louisiana |
| 4 | Secretary of State's office, to accept donations to assist with funding the |
| 5 | statutory missions of the Louisiana Bicentennial Commission and the Battle of |
| 6 | New Orleans Bicentennial Commission. |
| 7 | (2) The donations remitted to Louisiana Historical Legacy Incorporated |
| 8 | shall be used solely for the purposes provided for in Chapters 27 and 27-A of |
| 9 | <u>Title 25.</u> |
| 10 | (3) The annual reports required by R.S. 25:1238.5 and R.S. 25:1235 shall |
| 11 | include an accounting of refund donations received and a detailed explanation |
| 12 | of expenditures, as well as a description of the Louisiana Historical Legacy |
| 13 | Incorporated's activities. |
| 14 | Section 2. The provisions of this Act shall be applicable to taxable years beginning |
| 15 | on or after January 1, 2011 and before January 1, 2016. |
| 16 | Section 3. This Act shall become effective upon signature by the governor or, if not |
| 17 | signed by the governor, upon expiration of the time for bills to become law without signature |
| 18 | by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If |
| 19 | vetoed by the governor and subsequently approved by the legislature, this Act shall become |
| 20 | effective on the day following such approval. |
