## HOUSE CONCURRENT RESOLUTION NO. 161

## BY REPRESENTATIVES LANDRY AND DIXON

JUDGES: Requests an examination of the structure of the judiciary by the La. Supreme

A CONCURRENT RESOLUTION

2	To urge and request the Louisiana Supreme Court to conduct an examination of the court
3	system in this state to determine if the existing structure of the judiciary is the most
4	appropriate use of judicial resources, to develop a formula for the legislature to use
5	in determining the appropriate number of judges in each geographic region in this
6	state, and to report its findings and recommendations to the legislature prior to
7	February 1, 2012.
8	WHEREAS, it is in the best interest of the citizens of this state that the judiciary
9	work as efficiently as possible; and
10	WHEREAS, citizens who are involved in litigation have an expectation that legal
11	issues will be resolved in a reasonable amount of time thereby avoiding costly delays in civil
12	and criminal court; and
13	WHEREAS, citizens of this state also expect a sufficient number of judges in each
14	geographic area to handle the workload in that judicial district; and
15	WHEREAS, a thorough examination of the existing judicial structure is necessary
16	to determine if the existing structure is the most appropriate use of judicial resources; and
17	WHEREAS, this examination shall include a review of all judicial district courts and
18	the number of judges within each judicial district; and
19	WHEREAS, factors to be studied include caseload, use of support personnel,
20	diversity, case filing data, population, and the availability of parish courts, city courts, and
21	justice of the peace courts in each judicial district; and

1 WHEREAS, the Judicial Council was created by the Louisiana Legislature in 2003 2 and is required by the provisions of R.S. 13:61 to "adopt determinate standards and 3 guidelines" in determining whether new judgeships should be created and whether it is 4 necessary to split or merge the courts of appeal, district courts, city courts, parish courts, 5 juvenile courts, family courts, traffic courts, and municipal courts; and 6 WHEREAS, R.S. 13:61(E) specifically provides that the Judicial Council shall 7 review judicial districts and provide information and recommendations to the legislature on 8 the "appropriate number of district court judgeships within each district based upon caseload, 9 population, or other pertinent factors". 10 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 11 urge and request the Louisiana Supreme Court to conduct an examination of the court system 12 in this state to determine if the existing structure of the judiciary is the most appropriate use 13 of judicial resources, to develop a formula the legislature may use in determining the 14 appropriate number of judges in each geographic region in this state, and to report its 15 findings and recommendations to the legislature prior to February 1, 2012. 16 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
