Amendments proposed by Representative Tucker to Reengrossed House Bill No. 391 by Representative Tucker

1 AMENDMENT NO. 1

On page 1, line 2, after "amend Article" delete the remainder of the line and delete lines 3
through 19 and delete pages 2 through 9 and insert the following:

"VIII, Sections 5(E) and 12 of the Constitution of Louisiana, to provide for the
governance of postsecondary education; to provide relative to the powers of the
Board of Regents, the responsibilities of the management boards, and the
appropriation of funds for public postsecondary education; to provide for
submission of the proposed amendment to the electors; and to provide for related
matters.

10 Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the 11 members elected to each house concurring, that there shall be submitted to the 12 electors of the state of Louisiana, for their approval or rejection in the manner 13 provided by law, a proposal to amend Article VIII, Sections 5(E) and 12 of the 14 Constitution of Louisiana, to read as follows:

18 (E) Other Powers; Management Boards. Not Vested. Powers of management 19 over public institutions of postsecondary education not specifically vested by this Section in Subject to the policies of the Board of Regents are reserved to and the 20 21 powers specifically provided by this Section or by law to the Board of Regents, the 22 Board of Supervisors of Louisiana State University and Agricultural and Mechanical 23 College, the Board of Supervisors of Southern University and Agricultural and Mechanical College, the Board of Trustees for State Colleges and Universities 24 25 Supervisors for the University of Louisiana System, the Board of Supervisors of Community and Technical Colleges, and any other such board created pursuant to 26 27 this Article, as to shall be responsible for daily operations of the institutions under 28 the control of each.

- 30 §12. Appropriations; Higher Public Postsecondary Education
- 31Section 12. Appropriations for the institutions of higher public32postsecondary education shall be made to their managing boards the Board of33Regents. The funds appropriated shall be administered by the managing boards34Board of Regents and used solely as provided by law.
- Section 2. Be it further resolved that this proposed amendment shall be submitted
 to the electors of the state of Louisiana at the statewide election to be held on October 22,
 2011.

1	Section 3. Be it further resolved that on the official ballot to be used at said election
2	there shall be printed a proposition, upon which the electors of the state shall be permitted
3	to vote FOR or AGAINST, to amend the Constitution of Louisiana, which proposition shall
4	read as follows:
5	To provide that the public postsecondary education management boards'

powers are subject to policies and powers of the Board of Regents and to
require that appropriations for public postsecondary education be made to the
Board of Regents rather than to the management boards. (Amends Const.
Art. VIII, §§5(E) and 12)"
