Nine percent of the franchise fee paid pursuant to R.S. 27:91(C)(1) which is attributable to any riverboat gaming licensee operating in East Baton Rouge Parish beginning on or after July 1, 2011, and which pays additional franchise fees pursuant to the provisions of R.S. 27:91(C)(2) through (4), to the East Baton Rouge Parish Higher Education Improvement Fund, as provided in Subsection D of this Section.
- (iii) Nine percent of the license fee paid pursuant to R.S. 27:91(B)(2) which is attributable to any riverboat gaming licensee <u>operating outside of East Baton Rouge Parish or operating in East Baton Rouge Parish prior to July 1, 2011,</u> which pays additional franchise fees pursuant to the provisions of R.S. 27:91(C)(2) through (4) to the Support Education in Louisiana First Fund as provided in R.S. 17:421.7. Nine percent of the license fee paid pursuant to R.S. 27:91(B)(2) which is

15	as the East Baton Rouge Parish Higher Education Improvement Fund, hereinafter

18	Improvement Fund shall be appropriated each fiscal year by the legislature solely to
19	support institutions of higher learning located in East Baton Rouge Parish by
20	appropriating to the following foundations as follows:
