17	redesign, college and career readiness, workforce development, adult learning, and
18	workforce competitiveness, that are necessary to the fulfillment of the constitutional

20	are designed to promote excellence in order that every individual may develop to his
21	full potential, to comply with the provisions of Article VIII, Section 7.1(A) of the
22	Constitution of Louisiana, and in recognition of the critical importance and high

11	A. There is hereby created the High School Redesign College and Career
12	Readiness Commission, referred to in this Chapter as the "commission" for the
13	purpose of making recommendations for the development of statewide policies,
14	guiding principles, and programs that address the current and future economic needs
15	of the state and promoting student success in high school and in life beyond
16	secondary education.
17	B. The membership of the commission shall be as follows:
18	(1) The governor or her his designee.
19	(2) The state superintendent of education or his designee.
