3	elementary and secondary education; to provide with respect to the condition,
4	progress, and needs of public elementary and secondary schools; to provide with
5	respect to the annual report the superintendent is required to submit to specified
6	entities; to provide for a submission date for such report; to provide relative to the
7	Recovery School District; to provide that the superintendent of the Recovery School
8	District shall be subject to certain financial disclosure requirements; and to provide
9	for related matters.
10	Be it enacted by the Legislature of Louisiana:
11	Section 1. R.S. 17:22(7) is hereby amended and reenacted to read as follows:
12	§22. Superintendent; functions and duties
13	The superintendent shall:
14	* * *
15	(7)(a) Make an annual report to the board, the governor, and the legislature
16	on the condition of, the progress made, and the improvements needed in the public
17	elementary and secondary schools. The report shall contain the following:
18	(a) a (i) A complete financial report on the receipts and expenditures of the
19	department and of the various schools; .
20	(b) data (ii) Data concerning faculty, enrollment, graduates, courses of
21	study, and any other information required to show the condition, progress, and needs
22	of these schools <del>; and.</del>
23	(c) an (iii) An abstract of the reports of the parish city, parish, and other
24	local public school superintendents to the state superintendent, as well as all other
25	facts and statistics that are of interest to the public schools, and.
