## SENATE BILL NO. 154

### BY SENATOR MURRAY

Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana.

1	AN ACT
2	To amend and reenact R.S. 22:1053(A), (B), and (C), relative to health insurance; to provide
3	for coverage of step therapy or fail first protocols; to provide for any health care
4	coverage plan which includes prescription benefits as part of its policy or contract;
5	to provide for the duration of step therapy or fail first protocol when treatment is
6	deemed ineffective; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 22:1053(A), (B), and (C) are hereby amended and reenacted to read
9	as follows:
10	§1053. Requirement for coverage of step therapy or fail first protocols
11	A. Notwithstanding the provisions of R.S. 22:1047 to the contrary, any health
12	care coverage plan specified in Subsection D of this Section which includes
13	prescription benefits as part of its policy or contract, which utilizes step therapy
14	or fail first protocols, and which is issued for delivery, delivered, renewed, or
15	otherwise contracted for in this state on or after January 1, 2011, shall provide
16	coverage for step therapy or fail first protocols as provided in comply with the
17	<b>provisions of</b> this Section.
18	B. When medications for the treatment of any medical condition are restricted
19	for use by an insurer by a step therapy or fail first protocol, the prescribing physician
20	shall have access to a clear and convenient process to expeditiously request an
21	override of such restriction from the insurer. An override of such restriction shall be
22	expeditiously considered granted by the insurer under any of the following
23	circumstances:
24	(1) The prescribing physician can demonstrate to the health coverage plan,
25	based on sound clinical evidence, that the preferred treatment required under step
26	therapy or fail first protocol has been ineffective in the treatment of the insured's

1	disease or medical condition.
2	(2) The prescribing physician can demonstrate <u>to the health coverage plan</u> ,
3	based on sound clinical evidence, that the preferred treatment required under the step
4	therapy or fail first protocol is <b>reasonably</b> expected to be ineffective based on the
5	known relevant physical or mental characteristics and medical history of the
6	insured and known characteristics of the drug regimen.
7	(3) The prescribing physician can demonstrate <u>to the health coverage plan</u> ,
8	based on sound clinical evidence, that the preferred treatment required under the step
9	therapy or fail first protocol will cause or will likely cause an adverse reaction or
10	other physical harm to the insured.
11	C. The duration of any step therapy or fail first protocol shall not be longer
12	than the customary period for the medication when such treatment is deemed
13	demonstrated by the prescribing physician to be clinically ineffective by the
14	prescribing physician. When the prescribing physician health coverage plan can
15	demonstrate, through sound clinical evidence, that the originally prescribed
16	medication is likely to require more than the customary period for such medication
17	to provide any relief or an amelioration to the insured, the step therapy or fail first
18	protocol may be extended for <del>a</del> <b>an additional</b> period of time to be determined by the
19	physician no longer than the original customary period for the medication.
