AN ACT

To enact Subpart D-1 of Part VII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950, to be comprised of R.S. 49:148.4.1, relative to certain public buildings; to provide for suitable accommodation for breastfeeding and lactation; to provide specifications for design features; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. Subpart D-1 of Part VII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950, comprised of R.S. 49:148.4.1, is hereby enacted to read as follows:

SUBPART D-1. PUBLIC BUILDINGS - ACCOMMODATION FOR BREASTFEEDING AND LACTATION

§148.4.1. State-owned buildings; suitable accommodation for breastfeeding and lactation

A. The requirements set forth in this Section shall apply to the state-owned buildings, educational institutions, and office buildings provided for in Subsection C of this Section which are constructed, renovated, or remodeled in whole or in part by the use of state funds, or the funds of any board, commission, agency, or department of the state, referred to hereafter as "state buildings"; provided, however,

1 that the provisions of this Subpart shall not apply to buildings constructed by parish
2 or city school boards.

3 B. The state buildings provided for in Subsection C of this Section shall
4 provide suitable accommodation in the form of a room, other than a toilet stall, for
5 the exclusive use of women to breastfeed a child or express breast milk. Such
6 accommodation shall have, at minimum, all of the following features:

7 (1) A lockable door.

8 (2) A work surface and chair.

9 (3) Storage for cleaning supplies.

10 (4) Conveniently placed electrical outlets.

11 C. On or before July 1, 2014, the superintendent of the office of state
12 buildings shall cause to be constructed in exactly ten state buildings rooms of the
13 type provided for in this Subpart, in a number of at least one room per building. The
14 superintendent shall select the buildings in which the specified rooms shall be
15 constructed according to criteria including but not limited to the following:

16 (1) Cost minimization. The superintendent shall consider the particular
17 design aspects of different areas within public buildings in order to determine
18 feasibility of construction of the specified room and to carry out such construction
19 in a manner that minimizes cost.

20 (2) Demand for utilization. The superintendent shall consider the estimated
21 demand for utilization of the specified room by employees domiciled in the building
22 and the public.

23 D. Subject to appropriation, the office of state buildings may construct rooms
24 of the type provided for in this Subpart in a number of public buildings greater than
25 ten.

26 E. To carry out the provisions of this Subpart, the office of state buildings
27 may contract for and accept private contributions, gifts, and grants, or in-kind aid
28 from the federal government, the state, or any other source.

1 Section 2. This Act shall become effective on July 1, 2012.
